### **Code of Ethics**

1. To strive for the betterment of the Papillon breed and for the control / eradication of hereditary problems particular to the breed.
2. To maintain the highest standards of health and care for my dogs.
3. To sell only dogs for which Registration Papers will be provided and, in the case of puppies and adults which are of inferior or pet quality, to use CKC Non-Breeding contracts.
4. Not to sell puppies to pet shops or commercial brokers, nor donate puppies to auctions or raffles.
5. Not to sell puppies under the age of 9 weeks or without proper immunization and health protection for their age.
6. To represent my dogs as honestly as possible to prospective buyers and assist them with advice on diet, vaccinations and general health care.
7. To be an exemplary member of the club and refrain from detrimental public comment on any member or member's dogs.
